

Call for distribution of grants for international mobility from Partner Countries to the University of Almeria within the framework of the ERASMUS+ KA-171 program during the academic year 2025/26.

The Vice-Rector of International Relations, using the competences given by delegation of the Rector of the University of Almeria, as established in the Resolution 30/11/2023 of the University of Almeria (BOJA Number 234 - Thursday, December 7, 2023), opens this call to distribute grants for international mobility from Partner Countries to the University of Almeria during the academic year 2025/26. This call is funded by ERASMUS+ KA-171 ICM projects (2024-1-ES01-KA171-HED-000215826 and 2025-1-ES01-KA171-HED-000338868).

The University of Almeria offers Erasmus+ mobility grants for Professors and Administration Staff, distributed according to the following chart

Employees of partner universities included in this call are eligible for the following types of scholarships:

- For Professors that want to teach at UAL under a teaching program to be discussed with their assigned host at UAL: STA (Mobility for Teaching)**
- For Professors or Administration staff that want to participate in UAL's 2025 International Staff Week: STT (Mobility for Training)**

RULES OF THE CALL**1. GENERAL REQUIREMENTS FOR APPLICANTS**

Applicants must be employed at their home university at the time of the mobility and have at least a B2 level of **English** (for **Mobility for Training** applicants) or a B2 level of **English or Spanish** (for **Mobility for Teaching** applicants).

2. GRANT'S CONDITIONS:

2.1 For STT (Mobility for Training) grant holders: The beneficiary must attend UAL's 2026 International Staff Week, which will take place in late April 20-24, 2026. Click [here](#) to see 2025's programme.

2.2 For STA (Mobility for teaching) grant holders: The beneficiary must carry out a mobility of 5 consecutive days for at least 8 hours of teaching at UAL under a teaching program (content and dates to be discussed with their assigned host at UAL). The mobility must end no later than July 31st, 2026. The beneficiary may, with the approval of UAL's International Office, combine a Mobility for Teaching with a Mobility for Training. In that case the number of teaching hours is reduced to a minimum of 4.

2.3 Amount of the grant: The total amount of the grant is composed of the sum of the travel allowance and the individual support.

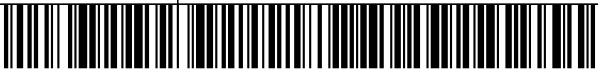
- **Travel allowance:** Contribution to travel expenses based on the distance between the University of Almeria and the partner university, according to the European Commission calculator ([link](#)).

Distance from home university to UAL	Travel allowance
+8.000 km	1.735 €
4.000-7.999 km	1.188 €
3.000-3.999 km	580 €
2.000-2.999 km	395 €

- **Individual support:** Grant holders will receive 170€ per day as contribution for room and board. UAL will add two extra days of individual support to all mobilities, that is, the scholarship offers a total of 7 days of individual support for all participants (total: 1190€).

3.1 Applications must be made online through the form published in the call's website (www.ual.es/internacionalizacion/movilidad-personal/erasmus-ka171-call-incoming-staff).

3.2 The deadline for applications is December 8th 2026 at 23:59 CET time.

3.3 Applications must include the following documents:

- "Support & certification letter" from home university (see page 5 of this call or the call's website.)
- Certificate of either English or Spanish language level, as required by section 1 of this call. If the candidate is a national of a country where English or Spanish is an official language, they will be considered to have a C2 level and it will be sufficient to send a copy of their passport through the application form.
- The application may also include a motivation letter, which will only be considered in case of tie among candidates.

4. DISTRIBUTION OF GRANTS

4.1 The distribution of grants will be made by a Selection Committee composed by the Vice-rector for International Relations (who will act as President of the Committee) or the person they delegate in; the Director of the Mobility Secretariat; the Head of the International Office; and a member of the International Office who will act as Secretary of the Committee, with voice but no vote.

4.2 The Selection Committee will take into consideration the following selection criteria:

a) Accredited knowledge of English or Spanish². If the candidate has accredited knowledge of both languages, only the higher level will be taken into account.

b) Seniority at home university

d) The candidate has supported Erasmus+ mobility as academic coordinator or host, or has significantly promoted the program 2 points

d) Motivation letter (optional document – It will only be considered in case of tie between candidate)
Up to 2 points

4.3 In the event of a tie, priority will be given to those with a higher score in their motivation letter.

5. AWARDING OF GRANTS

5.1 After the deadline for submission of applications, the Vice-Rector's Office for Internationalization will publish a Provisional Resolution indicating the score of the candidates after applying the scale of section 4 of these rules and (if any) the reason for their exclusion. The publication will be made in the following web page of the International Relations Office of the University of Almeria (<https://www.ual.es/internacionalizacion/movilidad-personal/erasmus-ka171-call-incoming-staff>).

5.2 Starting from the day of the Provisional Resolution's publication, participants who do not agree with their score or reason of exclusion, will have a period of 3 days (working days at UAL) to present allegations using the form published in the call's website.

5.3 Once the allegations have been resolved by the Selection Committee, the International Office will publish the Final Resolution.

5.4 All applicants who are not awarded a mobility grant will be placed on a waiting list according to their score on the scale, to cover possible resignations of the original awardees.

5.5 If any of the grants is not awarded, or if their holder drops out and the waiting list is empty, the Vice Rector may determine the allocation of those grants to other candidates from the same Erasmus+ country group and/or release a new call through urgent procedures respecting the principles of this call and/or relocate this funds for student mobilities.

6. COMMITMENT FROM GRANT AWARDEES

Applicants selected as recipients of an Erasmus mobility grant under this call are obliged to:

6.1 Before their mobility:

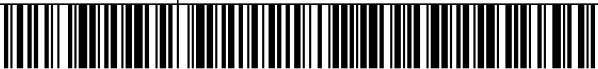
- Fill in and sign the Erasmus+ Mobility and Grant (financial) Agreement sent by UAL's International Office.
- Provide a proof of insurance covering their mobility period at UAL (health, accident, travel and repatriation).

6.2 After their mobility:

- Fill in the Erasmus+ Final Report they will receive by email.
